Subject: Freedom of Information Act 10-009

Dear Mr. Michaels:

This office has received your June 28, 2010, Freedom of Information Act (FOIA) requesting the following:

First, what is the document actually called? All I've been able to determine is its serial number (DE-AC04-79AL10752). Is it a Contract or a Cooperative Agreement? Is there a formal title or subtitle?

Second, what is the date of the contract? The serial number seems to indicate that it was signed in 1979, but I was wondering if there was also an associated day and month.

Third, what did it actually do? My understanding is that it provided funding for EEG from the Department of Energy. Is that the sole purpose of the contract? Or was that just one small piece of it?

Fourth, did the initial contract specify that DOE was to provide the SOLE source of funding for EEG, and did it specify the amount that was to be provided?

Fifth, did the contract specify that even though EEG would be funded by DOE, it would formally be located in a department of the State of New Mexico (if so, which one)? I am aware that it was initially part of the New Mexico Environmental Improvement Division, but eventually moved to the New Mexico Institute of Mining and Technology. I'm wondering if these changes happened vis-a-vis these contracts or through some other means.

Sixth, does the contract specify where the funding from DOE will come from? I have a note that after 1982, the funding came out of the Nuclear Waste Fund. I am curious whether this was also pursuant to a contract, or whether this change came through alternate means.
