The New Mexico Environment Department (NMED) has received the *Notification of Class 1 Permit Modifications: Revise a Course Outline; Revise Table and Panel Figures to Include Panel 7; Update Descriptions Related to Type B Packages; and Update TRUPACT-II and HalfPACT Figures*, dated August 29, 2013 and received August 30, 2013. 
