**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**

The purposes of this modification are to:

(1) Obligate funds of \$500,000 from LANL in accordance with Special Contract Clause H.55 – Work performed for other DOE entities. Total contract funding is increased from \$273,555,194.85, by \$500,000, to \$274,055,194.85.

(2) Increase the FY14 anticipated funding shown in Section B.2.2.(b) of the contract in accordance with Special Contract Clause H.55 – Work performed for other DOE entities. The line showing FY14 funding from other DOE entities is increased from \$651,584.32 (in Modification 67), by \$500,000, to \$1,151,684.32 in Mod 68 for LANL funding for commodities (PBS-VL-LANL-00131.01; Project 0002167).

(3) Increase contract value from \$1,387,183,619.06, by \$500,000, to \$1,387,683,619.06.
