**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**

The purposes of this modification are to:

(1) Obligate funds of \$5,931.69 for RAP in accordance with Special Contract Clause H.55 – Work performed for other DOE entities. Total contract funding is increased from \$426,722,237.66, by \$5,931.69, to \$426,728,169.35.

(2) Increase the FY15 anticipated funding shown in Section B.2.2.(b) of the contract in accordance with Special Contract Clause H.55 – Work performed for other DOE entities. The line showing FY15 funding from other DOE entities is increased from \$61,470.00 (in Modification 86), by \$5,931.69, to \$67,401.69 in Modification 89 for RAP funding provided by DOE-HQ.

(3) Increase contract value from \$1,417,883,489.66, by \$5,931.69, to \$1,417,889,421.35.
