 The purposes of this modification are to:
 1) Obligate funds of \$51,605.08 for RAP in accordance with Special Contract Clause H.55 – Work performed for other DOE entities. Total contract funding is increased from \$448,644,370.35, by \$51,605.08, to \$448,695,975.43.
 (2) Increase the FY15 anticipated funding shown in Section B.2.2.(b) of the contract in accordance with Special Contract Clause H.55 – Work performed for other DOE entities. The line showing FY15 funding from other DOE entities is increased from \$67,401.69 (in Modification 89), by \$51,605.08, to \$119,006.77 in Modification 92 for RAP funding provided by DOE-HQ.
 (3) Increase contract value from \$1,417,889,421.35 by \$51,605.08, to \$1,417,941,026.43.
 All other terms and conditions remain unchanged.
