# WIPP UPDATE: August 31, 2015

### **DOE Announces New Manager for the Carlsbad Field Office**

The Department of Energy (DOE) today announced the selection of Todd Shrader as the manager for the Carlsbad Field Office (CBFO).

"Todd Shrader is a proven leader and experienced engineer who has successfully tackled some of DOE's toughest issues," said Monica Regalbuto, Assistant Secretary for DOE's Office of Environmental Management (EM). "He is the right person to lead the excellent team we have in Carlsbad, as we all remain focused on safely resuming waste emplacement operations at the Waste Isolation Pilot Plant as quickly and efficiently as possible."

#### Mr. Shrader's past experience includes:

- Director of the headquarters office responsible for supporting Hanford's Office of River
  Protection. In this role, he has led DOE EM efforts with the State of Washington, including
  development of work scope, budget, and schedules for tank retrievals and the completion of the
  Waste Treatment Plant. He has also been a key contributor to the development of the revised
  path forward for the plant, including authoring the Framework document that describes the
  approach for completing the Waste Treatment Plant in phases, thus allowing for vitrification of
  waste to begin as soon as practicable.
- A project manager for the Office of Civilian Radioactive Waste Management, leading key
  components of the Nuclear Regulatory Commission (NRC) licensing process for the Yucca
  Mountain Project, including work on the safety basis, programmatic impacts, and long-term
  performance of a repository during NRC review. He was also the federal lead for the
  development of the portions of the license application describing the sub-surface repository
  engineering and design.

Various positions at the Hanford Site, including serving as the Hanford Site Transuranic (TRU)
 Waste Program manager and Hanford's representative to the DOE TRU Waste Corporate Board.
 He was also a conduct of operations subject matter expert with oversight responsibilities for
 waste management operations, including TRU waste retrieval, packaging, storage, and disposal.
 Finally, he also served as a Facility Area Engineer for the Waste Treatment Plant and gained
 valuable experience overseeing the construction of this large radiological/chemical processing
 facility.

Dana Bryson, the current Acting CBFO Manager, recently announced his retirement. Bryson and Shrader will be working together over the next couple of months to ensure a smooth transition.
