LANL Management has not developed and implemented an effective Quality Assurance program. LANL is the prime contractor; however, the Quality Assurance program and implementation documents rest within a sub tier organization. Effective implementation has suffered as evidenced by the number of adequacy issues and the use of implementing quality instructions that are not controlled per the audited/documented Quality Assurance program. Evidenced by the following:

- (1) Complete documentation exists for LANL Management involvement in the upper tier requirements documents (i.e., QAP and Test Plan); however, that same level of documentation does not exist in the CEMRC implementing procedures (i.e., there is no LANL documentation review required by document control procedure nor is there any evidence that LANL-CO has any involvement with these CEMRC implementing procedures);
- (2) LANL has not requested that CEMRC issue any specific implementing procedures necessary for LANL to perform Actinide Chemistry work; however, LANL has created Desktop Instruction and Task Plan Instruction that are not part of the implementing CEMRC Quality Assurance program. LANL-CO is using these Desktop Instructions to perform specific work. LANL-CO has also placed QAPD requirements to be implemented in the Desktop Instructions (i.e., M&TE control) and not in the CEMRC QA implementing procedures;
- (3) LANL review of the annual assessment of implementation and effectiveness of the QAP; however, no documentation is required of LANL to approve the specific nonconformance solutions as required by implementing procedure;
- (4) This is an on-going issue; in the last LANL-CO audit A-03-12 the following was identified: implementation of the QA Program for the TWBIR program implementation, performed by LANL-CO in accordance with SNL procedures, was indeterminate. One corrective action report (CAR), W-03-03, was issued by LANL prior to the audit to document the failure of LANL to follow the SNL QA program requirements in performing the TWBIR activities. This CAR was closed in relationship to SNL.
