1.0 INTRODUCTION

This document serves as a User's Manual for EPAUNI, as used by the Sandia National Laboratories for the Waste Isolation Pilot Plant (WIPP). It describes the code's purpose and function, the user's interaction with the code, and the models and methods employed by the code.

EPAUNI is a FORTRAN program used to identify the distribution of EPA Units among the Contact-Handled Transuranic (CH-TRU) waste stream and for the WIPP-Scale Remote Handled-Transuranic (RH-TRU) destined for the WIPP. EPAUNI reads radionuclide activities for seven key radionuclides (for each WIPP CH-TRU waste stream) from a single input file obtained from the Transuranic Waste Baseline Inventory Report (TWBIR) and then performs the following: (1) calculates the activities as a function of time by using analytical solutions, (2) determines the EPA Units associated with the radionuclides, and (3) generates the normalized distribution associated with the volumetric EPA Units.

2.0 FUNCTIONAL REQUIREMENTS

- **R.1** This program reads TWBIR data for seven key CH-TRU radionuclides for each waste stream identified as being sent to the WIPP site and calculates the radioactivity of these radionuclides as a function of time (up to the regulatory limit of 10,000 years after the closure of WIPP).
- **R.2** This program reads TWBIR data for ten key RH-TRU radionuclides for each waste stream identified as being sent to the WIPP site and calculates the radioactivity of these radionuclides as a function of time (up to the regulatory limit of 10,000 years after the closure of WIPP).
- **R.3** EPAUNI calculates the EPA Units due to the radionuclides at select time frames and determines the volumetric EPA Units for each waste stream. WIPP-SCALE volumetric EPA Units are also calculated.

3.0 REQUIRED USER TRAINING

In order to run the EPAUNI program successfully, the code user should have a basic knowledge of Open VMS and Digital Command Language, and should have access to the WIPP cluster of Alpha microcomputers or their equivalent.

To manipulate and/or interpret the results of EPAUNI, users should have the following background: (1) a basic understanding of probability, (2) a basic understanding of the WIPP PA process, including the definitions and usage of conceptual models and scenarios, and (3) an understanding of the EPA standards that address the management and disposal of the transuranic radioactive wastes listed in 40 CFR 191.

4.0 MODELS AND METHODS

The EPA Units will be calculated for key radionuclides only. The number of radionuclides is limited to a manageable number by noting that the Transuranic Baseline Inventory Database to be used in the WIPP PA calculations are dominated by only a few key radionuclides (that is, the top five radionuclides contribute to greater than 99.9% of the unit of waste value and 99.6% of the initial EPA Units for CH-TRU and RH-TRU, (Sanchez et al. 1997, Tables 1-2 and 1-3). The dominant CH-TRU radionuclides are the following: Am241, Pu238, Pu239, Pu240, and U234. The three parent radionuclides (Pu241, Cm244 and Pu238) are also used in the calculations. For RH-TRU, three additional key radionuclides are included: Cs137, Sr90 and U233.

5.0 CAPABILITIES AND LIMITATIONS OF THE SOFTWARE

The EPAUNI program performs radionuclide buildup and decay calculations on CH-TRU waste streams containing seven key radionuclides (for each WIPP CH-TRU waste stream) and at ten times after closure. The following are the key radionuclides for the CH-TRU waste stream: Am-241, Cm-244, Pu-238, Pu-239, Pu-240, Pu-241, and U-234 radionuclides. The following are the ten time periods of interest for the CH-TRU waste stream:

0, 100, 125, 175, 350, 1000, 3000, 5000, 7500, and 10,000 years.

The EPAUNI program has a limit of 970 waste streams and 10 time periods.

EPAUNI does not obtain the half-lives, and release limit values from the WIPP PA database. This makes the code machine independent. However, the values for WUF, half-lives, and release limits are hard coded in the main module of EPAUNI.

To add additional radionuclide waste stream data and to add or modify time periods, the NUWS and NUTIME parameters should be modified, respectively. If the NUTIME parameter is modified, then array TIME needs to be modified.

6.0 USER INTERACTIONS WITH THE SOFTWARE

EPAUNI executes on a DEC Alpha under OpenVMS. The output files generated by EPAUNI are as follows: EPU_DIAG\$OUT (optional diagnostics file), EPU\$DIA, EPU_ACTTVITY\$DIA (Diagnostic files), EPU\$OUT, EPU2\$OUT (Supplementary output files), and EPU\$DAT (standard output file). The EPAUNI code displays the following output on the terminal:

Version - 1.15 E P A U N I T This code was generated for the repository work. The code will perform the following: 1) Read a datafile generated from the TWBIR. 2) Calculate the activity of key radionuclides. 3) Using decayed data, calculate the EPA unit. 4) Determine the EPA Unit per unit volume along with the associated weighting (volume) for each CH-TRU waste stream destined for the WIPP facility. (RH-TRU is all grouped into one item.)

Stage #1 Completed -- TWBID read, Output files opened. Stage #2 Completed -- Analysis done, Output written. Stage #3 Completed -- Alternate Output written. Stage #4 Completed -- Output files closed.

7.0 DESCRIPTION OF INPUT FILES

EPAUNI requires two input files assigned to the logicals EPU\$INP and EPU_DIAG\$INP.

7.1 EPU\$INP Input File

This input file should contain the seven key CH-TRU radionuclides data or the ten key RH-TRU data. CH-TRU radionuclides data cannot be combined with RH-TRU radionuclides data in the same input file.

The required content and structure of the input file are as follows: for CH-TRU data, the first line in the input file must be character data beginning in column one with the keyword "*Stream*." This line must be followed by one or more lines of waste stream data that include the following: waste stream ID, volume (m³), and total activity (in curies) for the appropriate radionuclides. For CH-TRU, the appropriate radionuclides are the following: Am-241, Cm-244, Pu-238, Pu-239, Pu-240, Pu-241, and U-234. These activities must be entered in the order shown here. Data

values are delimited by spaces or tabs. An example of an input file for one CH-TRU waste stream is shown in Figure 2.

Similarly, for RH-TRU, the first two lines in the input file must be character data, with the first line beginning in column one with the keyword "*StreamRH*." The first two lines must be followed by one or more sets of two lines of waste stream data that include the following: waste stream ID, volume (m³), and total activity (in curies) for the appropriate radionuclides. For RH-TRU, the appropriate radionuclides are the following: Am-241, Cm-244, Pu-238, Pu-239, Pu-240, Pu-241, U-234, Cs-137, Sr-90, and U-233. These activities must be entered in the order shown here. Also, for each two-line set of waste stream data, the first seven activities must be on the first line, and the other three must be on the second line. Data values are delimited by spacesor tabs. An example of an input file for one RH-TRU waste stream is shown in Figure 3.

7.2 EPU_MISC\$INP Input File

EPAUNI reads the control files and WUF from the file assigned the logical EPU_MISC\$INP. The first five integers are IFLAGD, IFLAGO, IFLAGI, IFLAGR, and IFLAGC; while the second line is the WUF value. An example of an input file for the control files and WUF is shown in Figure 4.

8.0 ERROR MESSAGES

The EPAUNI program does not generate error messages.

9.0 DESCRIPTION OF OUTPUT FILES

EPAUNI can generate six output files. Many of these files are generated for diagnostic purposes. The output file EPU\$DAT contains the following information: waste stream number (ICH), normalized volume (PCH(ICH)), and volumetric EPA Units for nine time periods of interest (that is, 100, 125, 175, 350, 1000, 3000, 5000, 7500, and 10,000 years after closure, CCH(ICH,1)..CCH(ICH,ITMCH)). The NCH in the output defines the number of waste streams and NTMCH defines the number of time periods. For examples of the other output files, refer to Sanchez et al. 1997.

9.1 EPU\$OUT Output File

An example of an output file corresponding to a test case with a single CH-TRU waste stream is presented in Figure 5.
